The BOC has also resolved to issue the below mentioned instructions:

1. All provisionally/selected candidates are to deposit their original certificates (Matric certificate, Degree, Detail Marks Sheets, Reserved category certificates, Migration Certificate (as per prospectus) in the respective centers which have been allotted to them. In case of any discrepancy/misrepresentation in the documents, the seat will automatically stand cancelled.
2. The admission is **purely provisional** subject to the physical verification of the original documents as per point no. 1 above.
3. The selection is subject to the condition that if any wrong information is provided to the respective Department by the candidate the admission stand automatically cancelled and University has the right to recover for losses.
4. The admission is subject to the eligibility criteria mentioned in the prospectus.
5. The selected candidates must deposit fees by 31st October till 4.00 pm.
6. The fees may be deposited either by cash at the University Cash Counter/Net banking /Credit Card/Debit Card on the Student Life Cycle Portal (SLC Portal) on the University Website using Student ID and password generated at the time of filling application form.(This ID Password should be kept safe by the candidate during the entire course).
